Abstract

We study boundary value problems for a linear evolution equation with spatial derivatives of arbitrary order, on the domain 0 < x < L, 0 < t < T, with L and T positive finite constants. We present a general method for identifying well-posed problems, as well as for constructing an explicit representation of the solution of such problems. This representation has explicit x and t dependence, and it consists of an integral in the k-complex plane and of a discrete sum. As illustrative examples we solve some two-point boundary value problems for the equations $iq_t + q_{xx} = 0$ and $q_t + q_{xxx} = 0$.

1. Introduction

A new method for solving boundary value problems for linear and for integrable nonlinear PDEs in two dimensions has been recently introduced (see review [4]). In this paper we apply this method, and in particular the results of [7], to solve twopoint boundary value problems for a general linear dispersive evolution equation. Let the scalar function q(x,t) satisfy

$$\left(\partial_t + i\sum_{j=0}^n \alpha_j (-i\partial_x)^j\right) q(x,t) = 0, \quad 0 < x < L, \quad 0 < t < T, \tag{1.1}$$

where α_j are real constants, $\alpha_n \neq 0$, and L, T are positive constants. Let q(x, t) also satisfy the initial condition

$$q(x,0) = q_0(x), \quad 0 < x < L, \tag{1.2}$$

where $q_0(x)$ is a sufficiently smooth function.

The dispersion relation of equation $(1 \cdot 1)$ is given by

$$\omega(k) = \sum_{j=1}^{n} \alpha_j k^j. \tag{1.3}$$

The method we present identifies the set of boundary conditions that must be prescribed at x = 0 and at x = L in order for the resulting initial boundary value problem for equation (1.1) to be well posed. This method also yields the construction

of an explicit representation of the solution of such problems. This representation has explicit x and t dependence, and it consists of an integral in the k-complex plane, and of a discrete sum.

In order to describe the results proved in this paper, we define the following contours and domains in the k-complex plane.

Definition 1.1. Let D, D_+ and D_- be the domains in the k-complex plane defined by

$$D = \{k \in \mathbb{C} \colon \operatorname{Im} \omega(k) > 0\}, \quad D_+ = D \cap \mathbb{C}^+, \quad D_- = D \cap \mathbb{C}^-, \tag{1.4}$$

where \mathbb{C}^+ and \mathbb{C}^- indicate the upper and lower half plane, respectively.

$$\partial D_+, \ \partial D_-$$
 are the oriented boundaries of $D_+, \ D_-,$ (1.5)

where the orientation is such that D is on the left-hand side of the increasing direction of ∂D .

It is shown in [7] that the components of D are simply connected and unbounded, and that there exists an R > 0 such that, outside the curve $|\omega(k)| = R$, ∂D is the union of smooth disjoint simple contours that approach asymptotically, as $k \to \infty$, the rays of the variety $\operatorname{Im}(k+\alpha)^n = 0$, where $\alpha = \alpha_{n-1}/(n\alpha_n)$. Moreover, the following lemma holds [7].

LEMMA 1.1. Let D_R be defined by

$$D_R = \{k \in D: |\omega(k)| > R\}.$$
 (1.6)

Let $D_{R,+}$ and $D_{R,-}$ denote the part of D_R in \mathbb{C}^+ and \mathbb{C}^- respectively, i.e.

$$D_{R,+} = D_R \cap \mathbb{C}^+, \quad D_{R,-} = D_R \cap \mathbb{C}^-.$$

If R is sufficiently large, D_R has n components, $D_{R,+}$ has N components, and $D_{R,-}$ has n - N components, where N is given by

$$N = \begin{cases} n/2 & n \ even, \\ (n+1)/2 & n \ odd, & \alpha_n > 0, \\ (n-1)/2 & n \ odd, & \alpha_n < 0. \end{cases}$$
(1.7)

Definition 1.2. We denote by $D_{R,1}, D_{R,2}, \ldots, D_{R,N}$ the N components of $D_{R,+}$. We denote by $D_{R,N+1}, D_{R,N+2}, \ldots, D_{R,n}$ the n-N components of $D_{R,-}$.

The method discussed here has as its starting point the observation that any linear PDE in two dimensions, with constant coefficients, can be written as the condition that a certain differential 1-form w(x,t,k), $k \in \mathbb{C}$, is closed. Its implementation involves the following three steps.

Step 1. Assume the existence of a solution q(x, t) of $(1 \cdot 1)$, which is sufficiently smooth up to the boundary of the domain. By performing the spectral analysis of the 1-form associated with equation $(1 \cdot 1)$:

- (1.a) Construct an integral representation of the solution q(x, t) in terms of certain functions of k called the *spectral functions*. This is an immediate consequence of the closure of w(x, t, k). For the case of equation (1.1), the spectral functions are defined in terms of $q_0(x) = q(x, 0)$, $\partial_x^j q(0, t)$ and $\partial_x^j q(L, t)$, $0 \leq j \leq n 1$.
- $(1 \cdot b)$ Obtain the global relation satisfied by the spectral functions.

For equation $(1 \cdot 1)$, the implementation of this step yields (see Section 2):

PROPOSITION 1.1 (Representation of solutions of equation (1.1)). Assume that q(x,t) is a sufficiently smooth solution of (1.1). Then q(x,t) is given by

$$q(x,t) = \frac{1}{2\pi} \left\{ \int_{-\infty}^{\infty} e^{ikx - i\omega(k)t} \hat{q}_0(k) dk + \int_{\partial D_+} e^{ikx - i\omega(k)t} \hat{Q}(0,k) dk + \int_{\partial D_-} e^{ik(x-L) - i\omega(k)t} \hat{Q}(L,k) dk \right\}, \quad (1.8)$$

where

$$\hat{q}_0(k) = \int_0^L e^{-ikx} q_0(x) dx, \quad k \in \mathbb{C},$$
(1.9)

and the spectral functions $\hat{Q}(0,k)$, $\hat{Q}(L,k)$ are defined by

$$\hat{Q}(\alpha, k) = \sum_{j=1}^{n} \alpha_j \left(\hat{Q}_{j-1}(\alpha, k) + k \hat{Q}_{j-2}(\alpha, k) + \dots + k^{j-1} \hat{Q}_0(\alpha, k) \right),$$
$$\hat{Q}_j(\alpha, k) = \int_0^T e^{i\omega(k)t} (-i\partial_x)^j q(\alpha, t) dt, \quad j = 0, \dots, n-1, \quad k \in \mathbb{C}, \quad (1.10)$$

with $\alpha = 0, L$.

Moreover, the boundary values of q(x, t) satisfy the global relation

$$\hat{Q}(0,k) - e^{-ikL}\hat{Q}(L,k) = -\hat{q}_0(k) + e^{i\omega(k)T}\hat{q}_T(k), \quad k \in \mathbb{C},$$
(1.11)

where

$$\hat{q}_T(k) = \int_0^L e^{-ikx} q(x, T) dx.$$
 (1.12)

Step 2. Given $q_0(x) \in \mathbf{C}^{\infty}[0, L]$, assume the existence of an admissible set of functions $\{f_j(t), g_j(t)\}_{j=0}^{n-1}$, with respect to q_0 . A set is called *admissible* if the associated spectral functions, defined in terms of q_0, f_j , and $g_j, 0 \leq j \leq n-1$, satisfy the global relation of Step (1.b).

Define q(x,t) in terms of these spectral functions by the formula of Step $(1 \cdot a)$. Prove that q(x,t) satisfies the given PDE, and that $q(x,0) = q_0(x)$, $(-i\partial_x)^j q(0,t) = f_j(t)$, $(-i\partial_x)^j q(L,t) = g_j(t)$, $0 \le j \le n-1$.

For equation $(1 \cdot 1)$, the precise definition of admissible functions is given below.

Definition 1.3 (Admissible functions). Let $q_0(x) \in \mathbf{C}^{\infty}[0, L]$, and let $\omega(k)$ be defined by equation (1.3). Let $\{f_0(t), \ldots, f_{n-1}(t), g_0(t), \ldots, g_{n-1}(t)\}$ be a set of 2n sufficiently smooth functions such that $(-i\partial_x)^j q_0(0) = f_j(0), (-i\partial_x)^j q_0(L) = g_j(0), j = 0, \ldots, n-1.$

Let

$$\hat{F}(k) = \sum_{j=1}^{n} \alpha_j \left(\hat{f}_{j-1}(k) + k \hat{f}_{j-2}(k) + \dots + k^{j-1} \hat{f}_0(k) \right), \tag{1.13}$$

$$\hat{G}(k) = \sum_{j=1}^{n} \alpha_j \big(\hat{g}_{j-1}(k) + k \hat{g}_{j-2}(k) + \dots + k^{j-1} \hat{g}_0(k) \big), \qquad (1.14)$$

where

$$\hat{f}_{j}(k) = \int_{0}^{T} e^{i\omega(k)t} f_{j}(t) dt, \quad j = 0, \dots, n-1, \quad k \in \mathbb{C},$$
 (1.15)

$$\hat{g}_j(k) = \int_0^T e^{i\omega(k)t} g_j(t) dt, \quad j = 0, \dots, n-1, \quad k \in \mathbb{C}.$$
 (1.16)

The set of smooth functions $\{f_0(t), \ldots, f_{n-1}(t), g_0(t), \ldots, g_{n-1}(t)\}$ is called *admissible* with respect to $q_0(x)$ if and only if the functions $\hat{F}(k)$ and $\hat{G}(k)$ satisfy the following relation:

$$\hat{F}(k) - e^{-ikL}\hat{G}(k) = -\hat{q}_0(k) + e^{i\omega(k)T}\hat{a}(k), \quad k \in \mathbb{C},$$
(1.17)

where

$$\hat{a}(k) = \int_0^L e^{-ikx} a(x) dx,$$

and a(x) is some function belonging to the space $\mathbf{C}^{\infty}[0, L]$.

For equation $(1 \cdot 1)$, the implementation of Step 2 yields (see Section 3):

THEOREM 1.1 (Existence of solutions associated with an admissible set). Assume that $q_0(x) \in \mathbb{C}^{\infty}[0, L]$, and that the set of smooth functions $\{f_j(t), g_j(t)\}, 0 \leq j \leq n-1$, is admissible with respect to $q_0(x)$, see Definition 1.3.

Let $\hat{q}_0(k)$ be defined by equation (1.9), and let $\hat{F}(k)$ and $\hat{G}(k)$ be defined by equations (1.13) and (1.14), respectively.

Define q(x, t) as follows:

$$q(x,t) = \frac{1}{2\pi} \left\{ \int_{-\infty}^{\infty} e^{ikx - i\omega(k)t} \hat{q}_0(k) dk + \int_{\partial D_+} e^{ikx - i\omega(k)t} \hat{F}(k) dk + \int_{\partial D_-} e^{ik(x-L) - i\omega(k)t} \hat{G}(k) dk \right\}, \quad (1.18)$$

where $\omega(k)$ is given by (1·3), and D_+ and D_- are defined by (1·4). Then:

- (i) q(x,t) is the unique solution of equation (1·1) such that t → q(·,t) is a C[∞] map from [0,T] into C[∞][0,L];
- (ii) $q(x, 0) = q_0(x);$
- (iii) $(-i\partial_x)^j q(0,t) = f_j(t), \quad 0 \le j \le n-1;$
- (iv) $(-i\partial_x)^j q(L,t) = g_j(t), \quad 0 \le j \le n-1.$

Step 3. Given an appropriate set of boundary conditions at x = 0 and x = L, prove the existence of an admissible set, and compute $\hat{F}(k)$ and $\hat{G}(k)$ in terms of the given initial and boundary conditions.

As a particular concrete example, we prove in Section 4 the existence of an admissible set if the following set of boundary conditions are given:

$$\begin{array}{ll} (-i\partial_x)^j q(0,t) &= u_j(t), & 0 < t < T, & 0 \leq j \leq N-1, \\ (-i\partial_x)^l q(L,t) &= v_l(t), & 0 < t < T, & 0 \leq l \leq n-N-1, \end{array} \right\}$$
(1·19)

with N given by (1.7).

In order to state our result, we give some definitions.

Two-point boundary value problems for linear evolution equations 525 Definition 1.4. The map $\lambda_{l,m}: \overline{D_{R,m}} \to \overline{D_{R,l}}$ is the biholomorphic map defined by

$$\omega(\lambda_{l,m}(k)) = \omega(k), \forall k \in \overline{D_{R,m}};$$
(1.20)

the polynomials $\omega_{n-j}(k)$, $j = 0, \ldots, n$, are defined by

$$\omega_{n-j}(k) = \alpha_j + k\alpha_{j+1} + \dots + \alpha_n k^{n-j}.$$
(1.21)

If $1 \leq m \leq N$ then $\lambda_{l,m}(k)$ satisfies the following:

$$1 \leqslant m \leqslant N: \begin{cases} \lambda_{l,m}(k) \in D_+ & \text{if } 1 \leqslant l \leqslant N, \\ \lambda_{l,m}(k) \in D_- & \text{if } N+1 \leqslant l \leqslant n. \end{cases}$$
(1.22)

The definition of $\lambda_{l,m}$ implies

$$\begin{split} \hat{f}_j(k) &= \hat{f}_j(\lambda_{l,m}(k)), \quad \hat{g}_j(k) = \hat{g}_j(\lambda_{l,m}(k)); \\ \lambda_{l,m}(\lambda_{m,j}(k)) &= \lambda_{l,j}(k); \quad \lambda_{l,m}(k) \sim e^{i(l-m)2\pi/n}k, \quad k \to \infty. \end{split}$$

In order to state the main theorem, we need one further definition.

Definition 1.5. The $n \times n$ matrix A is defined by

where $E_l = e^{i\lambda_{l,m}L}$, and $\lambda_{l,m} = \lambda_{l,m}(k)$ is the map given by (1.20).

THEOREM 1.2 (Representation of the solution of the problem $(1\cdot 1)-(1\cdot 2)-(1\cdot 19)$). Let q(x,t) satisfy equation (1.1), the initial condition (1.2) and the boundary conditions (1.19). Assume that $q_0(x) \in \mathbf{C}^{\infty}[0, L]$, u_j , $v_l \in \mathbf{C}^{\infty}[0, T]$ and moreover that $(-i\partial_x)^j q_0(0) = u_j(0)$, $j = 0, \ldots, N-1$, and $(-i\partial_x)^l q_0(L) = v_l(0)$, $l = 0, \ldots, n-N-1$.

Then q(x,t) is given by equation (1·18), where $\hat{q}_0(k)$ is given by (1·9), and the spectral functions $\hat{F}(k)$, $\hat{G}(k)$ are defined by the formulas (1·13) and (1·14), in which $\hat{f}_j(k)$, $\hat{g}_j(k)$ are constructed as follows:

$$\hat{f}_j(k) = \hat{u}_j(k), \quad 0 \leq j \leq N-1, \quad k \in \mathbb{C}, \\ \hat{g}_l(k) = \hat{v}_l(k), \quad 0 \leq l \leq n-N-1, \quad k \in \mathbb{C}, \end{cases}$$

$$(1.24)$$

where $\hat{u}_j(k)$ and $\hat{v}_l(k)$ are given by

$$\hat{u}_j(k) = \int_0^T e^{i\omega(k)t} u_j(t) dt, \quad \hat{v}_l(k) = \int_0^T e^{i\omega(k)t} v_l(t) dt$$

 $\hat{f}_j(k)$, for $N \leq j \leq n-1$, and $\hat{g}_l(k)$, for $n-N-1 \leq l \leq n-1$, are given for $k \in D_{R,m}$,

 $1 \leq m \leq N, by$

$$\hat{f}_{N+j-1}(k) = \frac{\det B_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \sum_{h \in \mathbb{Z}} \det B_j(\lambda_{1,m}(k_h), \dots, \lambda_{n,m}(k_h))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))}$$

$$1 \leqslant j \leqslant n - N,$$
(1.25)

$$\hat{g}_{j-1}(k) = \frac{\det B_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \sum_{h \in \mathbb{Z}} \det B_j(\lambda_{1,m}(k_h), \dots, \lambda_{n,m}(k_h))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))}$$

$$n - N + 1 \leqslant j \leqslant n. \tag{1.26}$$

In the above formulas, R > 0 is sufficiently large, so that $D_{R,+}$ has N components; the map $\lambda_{l,m}: \overline{D_{R,m}} \to \overline{D_{R,l}}$ is defined by (1·20); the polynomials $\omega_{n-j}(k)$ are defined by (1·21); $B_j(\lambda_{1,m}, \ldots, \lambda_{n,m})$ is the matrix obtained by replacing the jth column of the $n \times n$ matrix A, defined by (1·23), by the vector $b(\lambda_{1,m}, \ldots, \lambda_{n,m})$, whose lth component is given by

$$b_{l} = \begin{cases} \sum_{j=1}^{n-N} \omega_{n-j}(\lambda_{l,m}) \hat{v}_{j-1}(k) - e^{i\lambda_{l,m}L} \left[\sum_{j=1}^{N} \omega_{n-j}(\lambda_{l,m}) \hat{u}_{j-1}(k) + \hat{q}_{0}(\lambda_{l,m}) \right], \\ 1 \leqslant l \leqslant N, \\ e^{-i\lambda_{l,m}L} \sum_{j=1}^{n-N} \omega_{n-j}(\lambda_{l,m}) \hat{v}_{j-1}(k) - \sum_{j=1}^{N} \omega_{n-j}(\lambda_{l,m}) \hat{u}_{j-1}(k) + \hat{q}_{0}(\lambda_{l,m}), \\ N+1 \leqslant l \leqslant n; \end{cases}$$
(1.27)

 Δ is the determinant of the $n \times n$ matrix A, and k_h are the zeros of Δ in the region $D_{R,m}$.

Remarks

1. In order to minimize technical difficulties, we have assumed that the given functions $q_0(x)$, $u_j(t)$ and $v_l(t)$ are \mathbf{C}^{∞} functions. Actually the formulae presented in Proposition 1.2 are valid even if the above functions belong to the functional Sobolev spaces discussed in [7]. The analysis for such spaces is substantially more complicated but it is similar to that presented in [7].

2. The important requirement for well posedness is that N boundary conditions are prescribed at x = 0 and n - N boundary conditions are prescribed at x = L. In this paper, for the sake of concreteness, we have assumed that $\partial_x^j q(0,t), 0 \leq j \leq N-1$, and $\partial_x^l q(L,t), 0 \leq l \leq n - N - 1$, are given. It is straightforward to derive similar formulas for any other N different values of j and n-N different values of l. It is also possible to derive similar formulas if linear combinations with constant coefficients of $\partial_x^j q(0,t)$ and of $\partial_x^l q(L,t)$ are given (see Example 5.1.2).

3. We recall that the method reviewed in [4] can also be applied to integrable nonlinear PDEs. Indeed, the method presented here, appropriately extended, can be applied to the nonlinear Schrödinger equation in 0 < x < L, 0 < t < T. It is interesting that the classical result of the initial value problem of the nonlinear Schrödinger equation with periodic boundary conditions is reproduced as a particular case of this analysis [6].

4. It is straightforward to generalise the formulas presented here to the case of forced equations, i.e. to the case that the right-hand side of equation $(1\cdot 1)$ is replaced by a given function F(x,t), see [7] for the case of $0 < x < \infty$. Thus the results presented here can be useful for the investigation of nonlinear *non-integrable* PDEs.

Indeed, in this case the nonlinear terms can be thought of as a forcing and hence at least for short time, or small data, it should be possible to obtain well posedness results.

5. The main difference between the results obtained here and those obtained for $0 < x < \infty$ appears in the analysis of the global relation satisfied by the boundary values of q(x,t) and of its derivatives. In our case, this analysis yields a system involving the matrix A which, in contrast to the case of $0 < x < \infty$, can be singular. This gives rise to a contribution in the integral representation of q(x,t) which takes the form of sums over the relevant singular points. This can be interpreted as the contribution of the discrete spectrum. The explicit representation of q(x,t) in terms of integrals and of sums is given in Proposition 4.1.

6. It can be shown that the solution representation is independent of T. Indeed, all formulae are valid, if T is replaced by t in the definition of $\hat{Q}(k)$ (the proof is analogous to the one given in [7]).

2. The spectral analysis

In this section we prove Proposition $1 \cdot 1$.

Equation $(1 \cdot 1)$ is the compatibility condition of

$$\left. \begin{array}{l} (\mu(x,t,k)e^{-ikx+iw(k)t})_x = e^{-ikx+iw(k)t}q(x,t), \\ (\mu(x,t,k)e^{-ikx+iw(k)t})_t = -e^{-ikx+iw(k)t}q_*(x,t,k), \end{array} \right\}$$
(2.1)

where

$$q_*(x,t,k) = \sum_{j=1}^n \alpha_j ((-i\partial_x)^{j-1} + k(-i\partial_x)^{j-2} + \dots + k^{j-1})q(x,t).$$

Equation $2 \cdot 1$ can be written in the form

$$d[e^{-ikx+i\omega(k)t}\mu] = w(x,t,k), \quad w(x,t,k) = e^{-ikx+i\omega(k)t}[qdx - q_*dt],$$
(2.2)

where the differential 1-form w is closed. Step $(1 \cdot a)$ of the method of [4] is to perform the spectral analysis of equation $(2 \cdot 2)$. This means finding a solution $\mu(x, t, k)$ of equation $(2 \cdot 1)$ bounded in $k \in \mathbb{C}$ for all (x, t) in $[0, L] \times [0, T]$.

Proof of Proposition 1.1. We start by showing that a solution of (2.1) bounded in $k \in \mathbb{C}$ has the form

$$\mu = \begin{cases} \mu_1, & k \in E_+ \\ \mu_2, & k \in D_+ \\ \mu_3, & k \in D_- \\ \mu_4, & k \in E_-, \end{cases}$$
(2.3)

where

$$E = \{k: \operatorname{Im} \omega(k) < 0\}, \quad E_{\pm} = E \cap \mathbb{C}^{\pm}, \tag{2.4}$$

and $\mu_i(x, t, k)$ are defined below in equation (2.5).

Let z = t + ix. If z_0 is an arbitrary constant, then by $\int_{z_0}^{z}$ we denote the line integral from z_0 to z. The function

$$\int_{z_0}^z e^{ik(x-x')-i\omega(k)(t-t')} [q(x',t')dx' - q_*(x',t',k)dt'],$$

is a particular solution of equation (2.1). Moreover, since w is a closed form, this solution does not depend on the choice of the smooth curve between z_0 and z.

It is shown in [5] that there exists a canonical way of choosing z_0 , namely, the corners of the polygon. Thus we define the following 'canonical' particular solutions [5]:

$$\mu_j(x,t,k) = \int_{z_j}^z e^{ik(x-x')-i\omega(k)(t-t')} [q(x',t')dx' - q_*(x',t',k)dt'], \quad j = 1, \dots, 4, \quad (2.5)$$

where $z_1 = 0$, $z_2 = T$, $z_3 = T + iL$ and $z_4 = iL$. The functions μ_j are entire functions of k; the general theory presented in [5] implies that these functions are also bounded as $k \to \infty$ provided that as $k \to \infty$, μ_j are defined in the domains indicated in (2·3). This also follows from computing the integrals in (2·5) along paths parallel to the x and t axis:

Equation (2.5) implies

Computing the integrals in (2.7) along paths parallel to the x and t axes, we find

$$\mu_{1} - \mu_{4} = e^{ikx - i\omega(k)t} \hat{q}_{0}(k), \qquad k \in E_{+} \cap E_{-}, \\ \mu_{2} - \mu_{1} = e^{ikx - i\omega(k)t} \hat{Q}(0, k), \qquad k \in D_{+} \cap E_{+}, \\ \mu_{2} - \mu_{3} = e^{ikx - i\omega(k)t} [\hat{Q}(0, k) - e^{-ikL} \hat{Q}(L, k) + \hat{q}_{0}(k)], \qquad k \in D_{+} \cap D_{-}, \\ \mu_{2} - \mu_{4} = e^{ikx - i\omega(k)t} [\hat{q}_{0}(k) + \hat{Q}(0, k)], \qquad k \in D_{+} \cap E_{-}, \\ \mu_{3} - \mu_{4} = e^{ikx - i\omega(k)t} e^{-ikL} \hat{Q}(L, k), \qquad k \in D_{-} \cap E_{-}, \\ \mu_{3} - \mu_{1} = e^{ikx - i\omega(k)t} [-\hat{q}_{0}(k) + e^{-ikL} \hat{Q}(L, k)], \qquad k \in D_{-} \cap E_{+}, \end{cases}$$

where $\hat{q}_0(k)$, $\hat{Q}(0,k)$ $\hat{Q}(L,k)$ are given by equations (1.9)–(1.10). The expression for $\mu(x,t,k)$ yields the estimate

$$\mu = O(1/k), \quad k \to \infty. \tag{2.9}$$

In addition, μ is a sectionally holomorphic function of k, as each of its representations μ_j is holomorphic. Equation (2.8) represents the jumps of μ along the curve separating the domains of analyticity of the various μ_j . Thus these equations and the asymptotic estimate (2.9) determine a well defined RH problem for μ ; the unique Two-point boundary value problems for linear evolution equations 529 solution of this problem is given by [1]

Since $q = \mu_x - ik\mu$, differentiating the above expression for μ , with respect to x, yields equation (1.8).

Since w is a closed form, its integral along the boundary of the polygon vanishes. Writing this relation explicitly for the polygon with vertices z_1, \ldots, z_4 , we obtain equation (1.11).

3. Proof of Theorem 1.1

We start by making a few technical simplifications, which we summarise in the following lemma. The proof is similar to the one presented in [7].

LEMMA 3.1. Given a set of functions $\{f_j(t), g_j(t)\}_{j=0}^{n-1}$, admissible with respect to $q_0(x)$, let $\hat{f}_j(k)$, $\hat{g}_j(k)$ be defined as in equations (1.15), (1.16).

(b) For $k \in D_{R,m}$, $1 \leq l \leq n$, and $1 \leq m \leq N$,

(a) There is no loss of generality in studying the reduced initial boundary value problem obtained when (1.2) is replaced by

and when it is assumed that the admissible functions $f_j(t)$, $g_j(t)$, $0 \le j \le n-1$, vanish to all orders at t = 0.

- (c) There is no loss of generality in extending $f_j(t)$, $g_j(t)$ to belong to the space $\mathbf{C}^{\infty}[0, T+1]$, and to vanish to all orders at t = T+1.
- (d) If each of the functions f_j(t), g_j(t) is in C[∞][0, T], and vanishes to all order at t = 0 and t = T, then the functions k^α(d^βF_j/dk^β), k^α(d^βG_j/dk^β) are bounded as k→∞ for all α, β positive integers, j = 0,..., n 1.

Proof of Theorem 1.1. Given the set of admissible functions $\{f_j(t), g_j(t)\}_{j=0}^{n-1}$, define $\hat{F}(k)$, $\hat{G}(k)$ by equations (1.13), (1.14). Using the polynomials defined by (1.21), we can write $\hat{F}(k)$ and $\hat{G}(k)$ as

1. q(x, t) solves the equation

The verification that q(x,t) is in $\mathbf{C}^{\infty}[0,L] \times \mathbf{C}^{\infty}[0,T]$ and that it satisfies equation (1.1) follows immediately from the results of Lemma 3.1.

2. The initial value

From $(3 \cdot 2)$ we obtain

We show that $(-i\partial_x)^j q(0,t) = f_j(t), 0 \leq j \leq n-1$; the verification for the boundary values at x = L is analogous. Evaluating the representation (3.2) at x = 0, we find

Using the property (a) of Lemma 3.1 we can show that

and k(z) is the solution of the equation $z = \omega(k)$ which, for $z \in C_R$, lies in $\partial D_{R,1}$. The Fourier inversion formula yields the claim.

4. Uniqueness

Suppose q_1 and q_2 are two solutions as in the statement of the theorem. Let $u = q_1 - q_2$. As in [7], it is easy to show that

$$\frac{d}{dt}\int_0^L |u(x,t)|^2 dt \leqslant 0, \qquad 0 \leqslant t \leqslant T.$$

Thus u = 0 and $q_1 = q_2$.

4. Proof of Theorem 1.2 and an alternative representation

We now use the definition and properties of an admissible set to show that, if the boundary conditions (1.19) are prescribed, then it is possible to compute explicitly the spectral functions $\hat{F}(k)$ and $\hat{G}(k)$. Once these spectral functions are known, the solution q(x,t) can be defined by equation (1.18).

PROPOSITION 4.1. Let

Associated with these admissible functions, there exist the following spectral functions:

The solution q(x, t) admits the representation (1.18), where the functions \hat{f}_j and \hat{g}_j are given by equations (1.24)–(1.26). Alternatively, this representation can be written in

where:

- (i) $\hat{f}_i, 0 \leq j \leq N$, and $\hat{g}_l, 0 \leq l \leq n N$, are given by equation (1.24);
- (ii) $B_j(\lambda_{1,m},\ldots,\lambda_{n,m})$ is the matrix obtained by replacing the *j*th column of $A(\lambda_{1,m},\ldots,\lambda_{n,m})$ by the vector $b(\lambda_{1,m},\ldots,\lambda_{n,m})$ defined in (1.27);
- (iii) Δ is the determinant of the $n \times n$ matrix A defined below by (1.23);
- (iv) $\{k_h\}$ are the zeros of Δ in the region $D_{R,m}$;
- (v) $\tilde{k}_h = \lambda_{l,m}(k_h);$
- (vi) Δ' denotes the derivative of Δ with respect to k.

Proof. We start by observing that, by deforming the contours ∂D_{-} and ∂D_{+} , equation (1.18) can be rewritten in the form

Equation (4.6) relates the 2n functions $\hat{f}_0(k), \ldots, \hat{f}_{n-1}(k), \hat{g}_0(k), \ldots, \hat{g}_{n-1}(k)$; however, they also contain the arbitrary function $\hat{a}(k)$.

Moving to the right-hand side the terms containing the known data $\hat{f}_{j-1}(k)$, $j = 1, \ldots, N$, and $\hat{g}_{j-1}(k)$, $j = 1, \ldots, n-N$, we obtain the following system for the spectral functions \hat{f}_j , $j = N, \ldots, n-1$ and $\hat{g}_l(k)$, $l = N - n, \ldots, n-1$:

= b_l + e^{iw(k)T} \hat{a}(\lambda_{l,m}), \quad (N+1) \leq l \leq n,

where $\{b_l\}_{l=1}^n$ is given by equation (1.27). It is important to note that all terms in this system are holomorphic functions, bounded for $k \in D_{R,m}$, $1 \leq m \leq N$.

We now write the system (4.7) in matrix form as

- (iii) $c(\lambda_{1,m},\ldots,\lambda_{n,m})$ is an *n*-vector whose *l*th component is given by

(iv) $(\cdot)^{\tau}$ denotes transposition.

Let $\Delta = \det(A)$. By induction, one can show that this determinant is always of the form

$$p(E_1, E_2, \ldots, E_N, E_{N+1}^{-1}, \ldots, E_n^{-1}) + r(k),$$

where p is a polynomial in the exponentials $E_1, \ldots, E_N, E_{N+1}^{-1}, E_n^{-1}$ with coefficients depending on k, and r(k) is a polynomial function of k of degree at most n(n+1)/2, with zero-th order term $r_0 \neq 0$. Since the exponentials $E_1, \ldots, E_N, E_{N+1}^{-1}, E_n^{-1}$ are analytic, bounded and decay as $k \to \infty$, for $k \in D_{R,m}$, $1 \leq m \leq N$, the term $1/\Delta$ is bounded for $k \in D_{R,m}$, except possibly for poles. We can use Cramer's rule, to solve this system explicitly for the functions $\hat{f}_N(k), \ldots, \hat{f}_{n-1}(k), \hat{g}_{n-N}(k), \ldots, \hat{g}_{n-1}(k)$, for

where $B_j(\lambda_{1,m},\ldots,\lambda_{n,m})$ is the matrix obtained by replacing the *j*th column of $A(\lambda_{1,m},\ldots,\lambda_{n,m})$ by the vector $b(\lambda_{1,m},\ldots,\lambda_{n,m})$, and $C_j(\lambda_{1,m},\ldots,\lambda_{n,m})$ is the matrix obtained by replacing the *j*th column of $A(\lambda_{1,m},\ldots,\lambda_{n,m})$ by the vector $c(\lambda_{1,m},\ldots,\lambda_{n,m})$.

The spectral functions $\hat{f}_{N+j-1}(k)$ and $\hat{g}_{j-1}(k)$ on the left-hand side of equations $(4\cdot9)-(4\cdot10)$ are holomorphic, bounded functions in $D_{R,m}$; moreover, since they are the Fourier transform of \mathbb{C}^{∞} functions, they must have at least $O(|k|^{-j})$ decay as $k \to \infty$. Equations $(4\cdot9)$ and $(4\cdot10)$ define these functions as the unique solution of the well defined system $(4\cdot7)$; thus the right-hand side of both equations $(4\cdot9)$ and $(4\cdot10)$ must have the same analyticity and boundedness properties. However the determinant $\Delta(k)$ may have zeroes in $D_{R,m}$, $1 \leq m \leq N$. For equations $(4\cdot9)-(4\cdot10)$ to be meaningful, we must subtract the contribution of the associated poles. Namely, suppose that $\Delta(\lambda_{1,m}(k_0), \ldots, \lambda_{n,m}(k_0)) = 0$, $k_0 \in D_{R,m}$. Since $\Delta \hat{f}_{N+j-1} = \det B_j + e^{i\omega(k)T} \det C_j$, and similarly for \hat{g}_{j-1} , it must be that, for $1 \leq j \leq n$,

$$\det B_j(\lambda_{1,m}(k_0),\ldots,\lambda_{n,m}(k_0)) + e^{i\omega(k_0)T} \det C_j(\lambda_{1,m}(k_0),\ldots,\lambda_{n,m}(k_0)) = 0.$$

As the function $\hat{a}(k)$ in the definition of the matrix C is unspecified, we can choose it in such a way that the latter equation is satisfied. Hence, we can subtract the resulting zero term, divided by Δ , from the expressions (4.9) and (4.10), and obtain

$$\hat{f}_{N+j-1}(k) = \frac{\det B_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \det B_j(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))} \\
+ e^{i\omega(k)T} \frac{\det C_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \det C_j(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))}, \\
1 \leqslant j \leqslant n - N,$$
(4·11)
$$\hat{g}_{j-1}(k) = \frac{\det B_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \det B_j(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))} \\
+ e^{i\omega(k)T} \frac{\det C_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k)) - \det C_j(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))}, \\
n - N + 1 \leqslant j \leqslant n.$$
(4·12)

The terms appearing on the right-hand side of equations $(4\cdot 11)-(4\cdot 12)$ are nonsingular at $k = k_0$, and define holomorphic functions in $D_{R,m}$, $1 \leq m \leq N$; moreover, because of the presence of the nonzero polynomial term r(k) in the expression of the determinant $\Delta(k)$, all these terms are also bounded and decaying. Hence equations $(4\cdot 11)-(4\cdot 12)$ are compatible with the known properties of the spectral functions.

We now show that the terms containing $\hat{a}(k)$ do not contribute to the representation of q(x,t). Indeed, the exponential term $e^{ikx+i\omega(k)(T-t)}$ is bounded and analytic for $k \in D_{R,+}$, $1 \leq m \leq N$; thus it follows that the integral

$$\int_{\partial D_{R,m}} e^{ikx - i\omega(k)t} \omega_{n-j}(k) e^{i\omega(k)T} \frac{\det C(\lambda_{1,m}, \dots, \lambda_{n,m})}{\Delta(\lambda_{1,m}, \dots, \lambda_{n,m})} dk$$

vanishes, except if the function Δ has zeroes inside the domain $D_{R,+}$, and the integration of the terms containing the exponential $e^{ikx-i\omega(k)(t-T)}$ is zero. Thus the term containing the function $\hat{a}(k)$ can be dropped from the system (4.7), and we can write the representation of the solution in the form (1.18).

We also note that computing explicitly in the integral representation (1.18) the contribution of the poles of $1/\Delta$, we obtain the explicit representation (4.3). Namely, consider the integral along $\partial D_{R,m}$, $1 \leq m \leq N$, of the function $\hat{f}_{N+j-1}(k)$ multiplied by the exponential $e^{ikx+i\omega(k)(T-t)}$; for $1 \leq j \leq n-N$, we obtain

$$\int_{D_{R,+}} e^{ikx - i\omega(k)t} \hat{f}_{N+j-1}(k) dk = \sum_{m=1}^{N} \left[\int_{D_{R,m}} e^{ikx - i\omega(k)t} \frac{\det B_j(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))}{\Delta(\lambda_{1,m}(k), \dots, \lambda_{n,m}(k))} dk - 2\pi i \ e^{ik_0x - i\omega(k_0)t} \frac{\det B_j(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))}{\Delta'(\lambda_{1,m}(k_0), \dots, \lambda_{n,m}(k_0))} \right].$$
(4.13)

Similarly, for $n - N + 1 \leq j \leq n$, if k_0 is a zero of Δ in $D_{R,l}$,

$$\int_{D_{R,-}} e^{ik(x-L)-i\omega(k)t} \hat{g}_{j-1}(k) dk = \sum_{l=N+1}^{n} \left[\int_{D_{R,l}} e^{ik(x-L)-i\omega(k)t} \frac{\det B_{j}(\lambda_{1,l}(k),\dots,\lambda_{n,l}(k))}{\Delta(\lambda_{1,l}(k),\dots,\lambda_{n,l}(k))} dk - 2\pi i \ e^{ik_{0}(x-L)-i\omega(k_{0})t} \frac{\det B_{j}(\lambda_{1,l}(k_{0}),\dots,\lambda_{n,l}(k_{0}))}{\Delta'(\lambda_{1,l}(k_{0}),\dots,\lambda_{n,l}(k_{0}))} \right].$$
(4.14)

The generalization of this case to any finite number of poles in straightforward. This representation is valid also in the case of infinitely many poles, provided that the relevant sums converge.

Remark 4.1. It is important to stress that the proof given above depends crucially on the fact that the term $1/\det(A)$ is bounded for $k \in D_{R,m}$. This is not the case for all sets of n given boundary conditions (see Remark 5.2.2 below for an example).

5. Examples

We compute explicitly the representation of the solution of some illustrative boundary value problems for a second and a third order equation.

Example $5 \cdot 1$.

$$iq_t + q_{xx} = 0, \quad 0 < x < L, \quad 0 < t < T.$$
 (5.1)

The closed 1-form associated to this equation is given by

$$w(x,t,k) = e^{-ikx+ik^2t} [qdx + (iq_x + kq)dt]$$




Fig. 1. The domains $D_{+} = D_{1}$ and $D_{-} = D_{2}$ for the equation $iq_{t} + q_{xx} = 0$.

Thus $\omega(k) = k^2$, and $D_+ = D_1$, $D_- = D_2$ are the domains shown in Fig. 1 and defined by

$$D_1 = \left\{k: 0 \leqslant \arg(k) \leqslant \frac{\pi}{2}\right\}, \quad D_2 = \left\{k: \pi \leqslant \arg(k) \leqslant \frac{3\pi}{2}\right\}.$$

The biholomorphic maps $\lambda_{l,m}(k)$ are given by

$$\lambda_{1,1}(k) = k, \quad \lambda_{2,1}(k) = -k.$$

A set of admissible functions with respect with the given initial data $q_0(x) = q(x, 0)$ contains four functions, $f_0(t)$, $f_1(t)$, $g_0(t)$, and $g_1(t)$. The spectral functions are given by

$$\hat{F}(k) = \int_0^T e^{ik^2 t} [f_1(t) + kf_0(t)] dt = \hat{f}_1(k) + k\hat{f}_0(k),$$
$$\hat{G}(k) = \int_0^T e^{ik^2 t} [g_1(t) + kg_0(t)] dt = \hat{g}_1(k) + k\hat{g}_0(k).$$

Hence, for $k \in D_1$, the global relation yields

$$e^{ikL} \left[\hat{f}_{1}(k) + k\hat{f}_{0}(k) \right] - \left[\hat{g}_{1}(k) + k\hat{g}_{0}(k) \right] = -e^{ikL}\hat{q}_{0}(k) + e^{ik^{2}T + ikL}\hat{a}(k), \\
 \left[\hat{f}_{1}(k) - k\hat{f}_{0}(k) \right] - e^{ikL} \left[\hat{g}_{1}(k) - k\hat{g}_{0}(k) \right] = -\hat{q}_{0}(-k) + e^{ik^{2}T}\hat{a}(-k).$$
(5.2)

These are two equations for the four functions $\hat{f}_0(k)$, $\hat{g}_0(k)$, $\hat{f}_1(k)$ and $\hat{g}_1(k)$. By assigning appropriately two boundary conditions, these equations yield a system of two equations for two unknowns, admitting a unique solution.

Although we have only shown this for the particular case that the value of the equation is given as boundary condition both at x = 0 and x = L, the same holds for other sets of boundary conditions (see Example 5.1.2 below).

Two-point boundary value problems for linear evolution equations 537 5.1.1 The boundary value problem for equation (5.1) defined by the initial and boundary conditions

$$q(x,0) = q_0(x), \qquad 0 < x < L, \tag{5.3}$$

$$q(0,t) = u_0(t), \qquad q(L,t) = v_0(t) \quad 0 < t < T, \tag{5.4}$$

where $q_0(x)$, $u_0(t)$ and $v_0(t)$ are smooth functions, compatible at x = t = 0 and at x = L, t = 0, is well posed. Its unique solution is given by

$$q(x,t) = \frac{1}{2\pi} \left\{ \int_{-\infty}^{\infty} e^{ikx - ik^2 t} \hat{q}_0(k) dk + \int_{\partial D_1} e^{ikx - ik^2 t} k \hat{u}_0(k) dk + \int_{\partial D_2} e^{ik(x-L) - ik^2 t} k \hat{v}_0(k) dk \right\} \\ + \left[\int_{\partial D_1} e^{ikx - ik^2 t} \frac{b_2(k) - e^{ikL}b_1(k)}{2\pi(1 - e^{2ikL})} dk + \sum_{h \in \mathbb{Z}} e^{ik_h x - ik_h^2 t} \frac{b_2(k_h) - e^{ik_h L}b_1(k_h)}{2L \ e^{2ikL}} \right] \\ + \left[\int_{\partial D_2} e^{ik(x-L) - ik^2 t} \frac{e^{-ikL}b_2(-k) - b_1(-k)}{2\pi(1 - e^{-2ikL})} dk + \sum_{h \in \mathbb{Z}} e^{-ik_h(x-L) - ik_h^2 t} \frac{e^{ik_h L}b_2(k_h) - b_1(k_h)}{2L \ e^{2ik_h L}} \right], \quad (5.5)$$

where $\hat{q}_0(k)$ is defined by (1.9), the functions $\hat{u}_0(k)$, $\hat{v}_0(k)$, $b_1(k)$, $b_2(k)$ are given by

$$\hat{u}_0(k) = \int_0^T e^{ik^2 t} u_0(t) dt, \quad \hat{v}_0(k) = \int_0^T e^{ik^2 t} v_0(t) dt, \quad (5.6)$$

 $b_1 = -e^{ikL}\hat{q}_0(k) - k \ e^{ikL}\hat{u}_0(k) + k\hat{v}_0(k), \quad b_2 = -\hat{q}_0(-k) + k\hat{u}_0(k) - e^{ikL}k\hat{v}_0(k), \quad (5.7)$ and k_h are given by

$$k_h = h\pi/L, \quad h \in \mathbb{Z}. \tag{5.8}$$

Indeed, let $E = e^{ikL}$. The known functions $\hat{f}_0(k)$ and $\hat{g}_0(k)$, are given by

$$\hat{f}_0(k) = \hat{u}_0(k), \quad \hat{g}_0(k) = \hat{v}_0(k).$$

For $k \in D_1$, the system (5.2) can be used to define $\hat{f}_1(k)$ and $\hat{g}_1(k)$

$$\begin{pmatrix} E & -1 \\ 1 & -E \end{pmatrix} \begin{pmatrix} \hat{f}_1(k) \\ \hat{g}_1(k) \end{pmatrix} = \begin{pmatrix} b_1 \\ b_2 \end{pmatrix} + \begin{pmatrix} a_1 \\ a_2 \end{pmatrix},$$

where $b_1(k)$, $b_2(k)$ are given by (5.7), and

$$a_1 = E \ e^{ik^2T} \hat{a}(k), \quad a_2 = e^{ik^2T} \hat{a}(-k).$$
 (5.9)

The determinant Δ of this system is given by

$$\Delta(k) = 1 - E^2 = 1 - e^{2ikL}, \tag{5.10}$$

and its solution is given by

$$\hat{f}_{1}(k) = \frac{b_{2} + a_{2} - E(b_{1} + a_{1})}{\Delta}$$
$$\hat{g}_{1}(k) = \frac{E(b_{2} + a_{2}) - (b_{1} + a_{1})}{\Delta}, \quad k \in D_{1}.$$

The terms containing a_1 and a_2 can be used to subtract the contribution of the poles arising from the zeros k_h of $1 - E^2$, given by (5.8). Indeed, choose a_1 and a_2 such

that $a_i(k_h) = -b_i(k_h)$, i = 1, 2; then \hat{f}_1 and \hat{g}_1 can be written as

$$\hat{f}_{1}(k) = \frac{b_{2} + a_{2} - E(b_{1} + a_{1}) - [b_{2} + a_{2} - E(b_{1} + a_{1})](k_{h})}{\Delta}
\hat{g}_{1}(k) = \frac{E(b_{2} + a_{2}) - (b_{1} + a_{1}) - [E(b_{2} + a_{2}) - (b_{1} + a_{1})](k_{h})}{\Delta}, \quad k \in D_{1}.$$
(5.11)

The expressions (5.11) now represent two bounded holomorphic functions.

Multiplying $\hat{f}_1(k)$ by e^{ikx-ik^2t} , and integrating along ∂D_1 , and similarly, multiplying $\hat{g}_1(k)$ by $e^{ik(L-x)-ik^2t}$, and integrating along ∂D_2 , it is easy to show that the terms containing a_1 and a_2 give no contribution, as the overall exponential is bounded in the whole of the region. We can also compute explicitly the residues due to the poles in the remaining terms; this gives

$$i\sum_{h=-\infty}^{\infty} e^{ik_h x - ik_n^2 t} \frac{b_2(k_h) - E(k_h)b_1(k_h)}{\Delta'(k_h)}, \quad i\sum_{h=-\infty}^{\infty} e^{-ik_h (x-L) - ik_n^2 t} \frac{b_1(k_h) - E(k_h)b_2(k_h)}{\Delta'(k_h)}.$$
(5.12)

Replacing the above functions in the representation $(4\cdot3)$, we obtain $(5\cdot5)$. Note that the two sums in $(5\cdot12)$ can be rewritten as

$$-\frac{1}{2L}\left[\sum_{h=-\infty}^{\infty}e^{i\pi hx/L-i(\pi h/L)^2t}b_2\left(\frac{h\pi}{L}\right)-\sum_{h=-\infty}^{\infty}e^{i\pi hx/L-i(\pi h/L)^2t}(-1)^hb_1\left(\frac{h\pi}{L}\right)\right],$$

and

$$\frac{1}{2L}\left[\sum_{h=-\infty}^{\infty}e^{-i\pi h(x-L)/L-i(\pi h/L)^2t}b_1\left(\frac{h\pi}{L}\right)-\sum_{h=-\infty}^{\infty}e^{-i\pi h(x-L)/L-i(\pi h/L)^2t}(-1)^hb_2\left(\frac{h\pi}{L}\right)\right].$$

Since the functions $b_1(k)$, $b_2(k)$ depend only on the Fourier coefficients $\hat{q}_0(k)$, $\hat{u}_0(k^2)$, $\hat{v}_0(k^2)$, if the given data $q_0(x)$, $u_0(t)$, $u_0(t)$ are sufficiently smooth both the trigonometric series in (5.12) converge.

 $5 \cdot 1 \cdot 2$ The boundary value problem for equation (5.1) defined by the initial condition (5.3) and by the boundary condition

$$\left. \begin{array}{l} q_x(0,t) + \beta q(0,t) &= u_0(t), \\ q_x(L,t) + \beta q(L,t) &= v_0(t), \quad 0 < t < T, \end{array} \right\}$$
(5.13)

where β is a constant, is well posed. The solution, for the case that $u_0 = v_0 = 0$, is given by

$$q(x,t) = \frac{1}{2\pi} \int_{-\infty}^{\infty} e^{ikx - ik^{2}t} \hat{q}_{0}(k) dk + \frac{2\beta e^{i\beta^{2}t}}{e^{-2\beta L} - 1} \left[e^{-\beta x} \hat{q}_{0}(-i\beta) - e^{\beta x + 2\beta L} \hat{q}_{0}(i\beta) \right] \\ + \sum_{h \in \mathbb{Z}} e^{ik_{h}x - ik_{h}^{2}t} \frac{\left[e^{2ik_{h}L} \hat{q}_{0}(k_{h}) - (i\beta + k_{h}/i\beta - k_{h})\hat{q}_{0}(-k_{h}) \right]}{2L \ e^{2ik_{h}L}} \\ - \sum_{h \in \mathbb{Z}} e^{-ik_{h}(x - 2L) - ik_{h}^{2}t} \frac{\left[\hat{q}_{0}(-k_{h}) - (i\beta - k_{h}/i\beta + k_{h})\hat{q}_{0}(k_{h}) \right]}{2L \ e^{2ik_{h}L}}, \tag{5.14}$$

where $\hat{q}_0(k)$ is defined by (1.9) and k_h are given by (5.8). A similar expression is found when $u, v \neq 0$.

Two-point boundary value problems for linear evolution equations 539 Let E be defined as in 5.1.1. The boundary condition implies that

$$\hat{f}_1(k) = i\beta \hat{f}_0(k) + \hat{u}_0(k), \quad \hat{g}_1(k) = i\beta \hat{g}_0(k) + \hat{v}_0(k);$$

thus the system $(5 \cdot 2)$ becomes

$$\begin{pmatrix} E(i\beta+k) & -(i\beta+k) \\ (i\beta-k) & -E(i\beta-k) \end{pmatrix} \begin{pmatrix} \hat{f}_0(k) \\ \hat{g}_0(k) \end{pmatrix} = \begin{pmatrix} b_1 \\ b_2 \end{pmatrix} + \begin{pmatrix} a_1 \\ a_2 \end{pmatrix},$$

where

$$b_1(k) = \hat{v}_0(k) - E\hat{u}_0(k) - E\hat{q}_0(k), \quad b_2(k) = E\hat{v}_0(-k) - \hat{u}_0(-k) - \hat{q}_0(-k),$$

 a_1 , a_2 are given by equation (5.9), and $\hat{q}_0(k)$ is given by (1.9). The determinant of this system is given by

$$\Delta = (E^2(k) - 1)(\beta^2 + k^2).$$

Since $\lim_{k\to\infty} 1/\Delta = 0$, the system can be solved uniquely; its solution is given by

$$\begin{aligned} \hat{f}_0(k) &= \frac{1}{\Delta} \left[(i\beta + k)(b_2 + a_2) - E(i\beta - k)(b_1 + a_1) \right], \\ \hat{g}_0(k) &= \frac{1}{\Delta} \left[E(i\beta + k)(b_2 + a_2) - (i\beta - k)(b_1 + a_1) \right], \quad k \in D_1. \end{aligned}$$

Substituting these spectral functions in the general representation (1.18), and dropping the terms containing a_1 or a_2 , we find that the integrand of the integral along ∂D_1 is

$$\frac{e^{ikx-ik^2t}}{1-E^2(k)} \left[E^2(k)(\hat{q}_0(k) - \hat{u}_0(k)) - E\hat{v}_0(k) + \frac{i\beta + k}{i\beta - k} \left(E\hat{v}_0(-k) - \hat{u}_0(-k) - \hat{q}_0(-k) \right) \right] + e^{ikx-ik^2t} \hat{u}_0(k),$$

while the integrand of the integral along ∂D_2 is

$$\begin{aligned} \frac{e^{ik(x-L)-ik^2t}}{E^2(-k)-1} \bigg[E(-k)(\hat{q}_0(k) - \hat{u}_0(-k)) - \hat{v}_0(-k) \\ &+ \frac{i\beta+k}{i\beta-k} \left(E(-k)\hat{v}_0(-k) - \hat{u}_0(-k) - \hat{q}_0(-k) \right) \bigg] + e^{ik(x-L)-ik^2t} \hat{v}_0(-k). \end{aligned}$$

The zeros of the functions $E^2 - 1$ and $i\alpha - k$ inside D_1 occur at the points $k = k_h$, with k_h given by (5.8), and at the point $k = i\alpha$. Computing the contribution due to these zeros, and simplifying the result when $u_0 = v_0 = 0$, we obtain the representation (5.14).

Example $5 \cdot 2$.

$$q_t + q_{xxx} = 0, \quad 0 < x < L, \quad 0 < t < T.$$
(5.15)

The closed 1-form associated to this equation is given by

$$w(x, t, k) = e^{-ikx - ik^{3}t} [qdx - (q_{xx} + ikq_{x} - k^{2}q)dt].$$




Fig. 2. The domains $D_+ = D_1$ and $D_- = D_2 \cup D_3$ for the equation $q_t + q_{xxx} = 0$.

Thus $\omega(k) = -k^3$, and $D_+ = D_1$, $D_- = D_2 \cup D_3$ are the domains shown in Fig. 2 and defined by

$$D_1 = \left\{k: \frac{\pi}{3} \leqslant \arg(k) \leqslant \frac{2\pi}{3}\right\},$$
$$D_2 = \left\{k: \pi \leqslant \arg(k) \leqslant \frac{4\pi}{3}\right\}, \quad D_3 = \left\{k: \frac{5\pi}{3} \leqslant \arg(k) \leqslant 2\pi\right\}.$$

The biholomorphic maps $\lambda_{l,m}(k)$ are given by

$$\lambda_{1,1}(k) = k, \quad \lambda_{2,1}(k) = \zeta k, \quad \lambda_{3,1}(k) = \zeta^2 k; \quad \zeta = e^{-2\pi i/3}.$$

A set of admissible functions with respect with the given initial data $q_0(x) = q(x, 0)$ contains six functions, $f_0(t)$, $f_1(t)$, $f_2(t)$, $g_0(t)$, $g_1(t)$ and $g_2(t)$. The spectral functions are given by

$$\hat{F}(k) = \int_0^T e^{-ik^3 t} [f_2(t) + ikf_1(t) - k^2 f_0(t)] dt$$

= $\hat{f}_2(k) + k\hat{f}_1(k) - k^2 \hat{f}_0(k),$
 $\hat{G}(k) = \int_0^T e^{-ik^3 t} [g_2(t) - ikg_1(t) - k^2 g_0(t)] dt$
= $\hat{g}_2(k) + k\hat{g}_1(k) - k^2 \hat{g}_0(k).$

Hence for $k \in D_1$, the global relation yields

$$\begin{array}{c} e^{ikL} \left[\hat{f}_{2}(k) + k\hat{f}_{1}(k) + k^{2}\hat{f}_{0}(k) \right] &- \left[\hat{g}_{2}(k) + k\hat{g}_{1}(k) + k^{2}\hat{g}_{0}(k) \right] \\ &= e^{ikL}\hat{q}_{0}(k) + e^{-ik^{3}T + ikL}\hat{a}(k), \\ \left[\hat{f}_{2}(k) + \zeta k\hat{f}_{1}(k) + \zeta^{2}k^{2}\hat{f}_{0}(k) \right] &- e^{-i\zeta kL} \left[\hat{g}_{2}(k) + \zeta k\hat{g}_{1}(k) + \zeta^{2}k^{2}\hat{g}_{0}(k) \right] \\ &= \hat{q}_{0}(\zeta k) + e^{-ik^{3}T}\hat{a}(\zeta k), \\ \left[\hat{f}_{2}(k) + \zeta^{2}k\hat{f}_{1}(k) + \zeta k^{2}\hat{f}_{0}(k) \right] &- e^{-i\zeta^{2}kL} \left[\hat{g}_{2}(k) + \zeta^{2}k\hat{g}_{1}(k) + \zeta k^{2}\hat{g}_{0}(k) \right] \\ &= \hat{q}_{0}(\zeta^{2}k) + e^{-ik^{3}T}\hat{a}(\zeta^{2}k). \end{array} \right\}$$

This is a system of three equations for six unknowns. Assigning appropriately three boundary conditions, this becomes a system of three equations for three unknowns, admitting a unique solution. Although we have only proved this claim for the particular case that the boundary conditions q(0,t), q(L,t) and $q_x(L,t)$ are assigned, the same holds true for other sets of boundary conditions, but not all set of three boundary conditions will yield a well defined system (see Example 5.2.2).

 $5 \cdot 2 \cdot 1$ The boundary value problem for equation (5.15) defined by the initial and boundary conditions

$$q(x,0) = q_0(x), \quad 0 < x < L, \tag{5.17}$$

$$q(0,t) = u_0(t), \quad q(L,t) = v_0(t), \quad q_x(L,t) = v_1(t), \quad 0 < t < T,$$
 (5.18)

where $q_0(x)$, $u_0(t)$, $v_0(t)$ and $v_1(t)$ are smooth functions, compatible at x = t = 0 and at x = L, t = 0, is well posed. The unique solution $q(x,t) \in \mathbf{C}^3[0,L] \times \mathbf{C}^1[0,T]$ is given by

$$\begin{split} q(x,t) &= \frac{1}{2\pi} \left\{ \int_{-\infty}^{\infty} e^{ikx+ik^{3}t} \hat{q}_{0}(k) dk \\ &+ \int_{\partial D_{1}} e^{ikx+ik^{3}t} (-k^{2} \hat{u}_{0}(k)) dk + \int_{\partial D_{2} \cup \partial D_{3}} e^{ik(x-L)+ik^{3}t} (-k\hat{v}_{1}(k) - k^{2} \hat{v}_{0}(k)) dk \right\} \\ &+ \int_{\partial D_{1}} e^{ikx+ik^{3}t} \frac{-k\tilde{B}_{1}(k) - \tilde{B}_{2}(k)}{2\pi\Delta(k)} dk + \int_{\partial D_{2}} e^{ik(x-L)+ik^{3}t} \frac{-\tilde{B}_{3}(\zeta k)}{2\pi\Delta(\zeta k)} dk \\ &+ \int_{\partial D_{3}} e^{ik(x-L)+ik^{3}t} \frac{-\tilde{B}_{3}(\zeta^{2}k)}{2\pi\Delta(\zeta^{2}k)} dk - i\sum_{h} e^{ik_{h}^{3}t} \frac{e^{ik_{h}x}(-k_{h}\tilde{B}_{1}(k_{h}) - \tilde{B}_{2}(k_{h}))}{\Delta'(k_{h})} \\ &- i\sum_{h} e^{ik_{h}^{3}t} \frac{e^{i\zeta k_{h}(x-L)}(-\tilde{B}_{3}(k_{h})) + e^{i\zeta^{2}k_{h}(x-L)}(-\tilde{B}_{3}(k_{h}))}{\Delta'(k_{h})}, \end{split}$$
(5.19)

where $\hat{q}_0(k)$ is defined by (1.9),

$$\begin{aligned} \hat{u}_0(k) &= \int_0^T e^{-ik^3 t} u_0(t) dt, \\ \hat{v}_0(k) &= \int_0^T e^{-ik^3 t} v_0(t) dt, \quad \hat{v}_1(k) = \int_0^T e^{-ik^3 t} (-iv_1(t)) dt, \end{aligned}$$

the functions $\tilde{B}_1(k)$, $\tilde{B}_2(k)$ and $\tilde{B}_3(k)$ are explicitly expressed in terms of the given data, see equations (5·22) and (5·24), the determinant $\Delta(k)$ is given by

$$\Delta = \frac{(\zeta - 1)e^{ikL}}{\zeta^2} k(e^{-ikL} + \zeta^2 e^{-i\zeta^2 kL} + \zeta e^{-i\zeta kL}), \quad \zeta = e^{-2\pi i/3}, \tag{5.20}$$

 k_h are the zeros of Δ in the region D_1 , and $\Delta'(k)$ denotes the derivative with respect to k.

Indeed, let E, E_2, E_3 be defined by

$$E = e^{ikL}, \quad E_2 = e^{-i\zeta kL}, \quad E_3 = e^{-i\zeta^2 kL},$$
 (5.21)

with ζ given in (5.20). For $k \in D_1$, the system (5.16) can be used to define the unknown functions $\hat{f}_1(k)$, $\hat{f}_2(k)$ and $\hat{g}_2(k)$:

$$\begin{pmatrix} Ek & E & -1\\ \zeta k & 1 & -E_2\\ \zeta^2 k & 1 & -E_3 \end{pmatrix} \begin{pmatrix} \hat{Q}_1(0,k)\\ \hat{Q}_2(0,k)\\ \hat{Q}_2(L,k) \end{pmatrix} = \begin{pmatrix} b_1\\ b_2\\ b_3 \end{pmatrix} + \begin{pmatrix} a_1\\ a_2\\ a_3 \end{pmatrix},$$

where

$$\left. \begin{array}{l} b_1 = E\hat{q}_0(k) - k^2 E\hat{f}_0(k) + k^2 \hat{g}_0(k) + k \hat{g}_1(k), \\ b_2 = \hat{q}_0(\zeta k) - \zeta^2 k^2 \hat{f}_0(k) + E_2 \left(\zeta^2 k^2 \hat{g}_0(k) + \zeta k \hat{g}_1(k)\right), \\ b_3 = \hat{q}_0(\zeta^2 k) - \zeta k^2 \hat{f}_0(k) + E_3 \left(\zeta k^2 \hat{g}_0(k) + \zeta^2 k \hat{g}_1(k)\right), \end{array} \right\}$$

$$(5.22)$$

and

$$\left. \begin{array}{l} a_{1} = e^{-ik^{3}T + ikL} \hat{a}(k), \\ a_{2} = e^{-ik^{3}T} \hat{a}(\zeta k), \\ a_{3} = e^{-ik^{3}T} \hat{a}(\zeta^{2}k). \end{array} \right\}$$

$$(5.23)$$

The determinant Δ of this system is given by equation (5.20), and its unique solution is given by

$$\hat{Q}_{1}(0,k) = \frac{\hat{B}_{1}(k)}{\Delta(k)},$$

$$\tilde{B}_{1}(k) = (b_{1} + a_{1})(E_{2} - E_{3}) + (b_{2} + a_{2})(EE_{3} - 1) - (b_{3} + a_{3})(EE_{2} - 1),$$

$$\hat{Q}_{2}(0,k) = \frac{\tilde{B}_{2}(k)}{\Delta(k)},$$

$$\tilde{B}_{2}(k) = (b_{1} + a_{1})\zeta k(E_{3} - \zeta E_{2}) + b_{2} + a_{2})k(\zeta^{2} - EE_{3}) + (b_{3} + a_{3})k(EE_{2} - \zeta),$$

$$\hat{Q}_{2}(L,k) = \frac{\tilde{B}_{3}(k)}{\Delta(k)},$$

$$\tilde{B}_{3}(k) = (b_{1} + a_{1})\zeta k(1 - \zeta) + b_{2} + a_{2})Ek(\zeta^{2} - 1) - (b_{3} + a_{3})Ek(\zeta - 1).$$
(5.24)

The determinant $\Delta(k)$ vanishes at k = 0 and at the roots of the equation

$$e^{-ikL} + \zeta^2 e^{-i\zeta^2 kL} + \zeta e^{-i\zeta kL} = 0.$$

The convergence of the series corresponding to these zeros depends as before on the smoothness of the given data.

Remark 5.2.2. It is noted in [8] that if in Example 5.2.1, the conditions (5.18) are replaced by

$$q(0,t) = u_0(t), \quad q_x(0,t) = u_1(t), \quad q(L,t) = v_0(t), \quad 0 < t < T,$$

the resulting initial boundary value problem appears *not* to be well posed. This is due to the fact that, in this case, the determinant of the resulting system is such that $1/\Delta$ is not bounded at infinity inside the region D_i , i = 1, 2, 3; hence the system cannot be solved.
